2. Only entries on a valid receipt with full contact details including full name and phone number will be accepted as a valid entry in-Centre OR online entry via the official online entry form with upload of a valid tax receipt from a City Centre Plaza retailer in the competition period. Note eftpos machine receipts will not be accepted as a valid tax receipt.
3. Customers may only enter when they have spent \$10 or more at any food, specialty store or service provider or \$50 at Coles or Target, in one transaction on any one day.
4. Only one (1) entry can be submitted per person, per transaction.
