



CITY CENTRE PLAZA - CHRISTMAS SPEND & WIN COMPETITION 2025

- 1. To enter, customers must spend \$10 or more at any specialty store, or \$50 or more at Coles or Target in one transaction on any one day.
- 2. Only entries on a valid receipt with full contact details including Full Name and Phone Number will be accepted as a valid entry in-Centre OR online entry via the official online Entry Form with upload of a valid Tax Receipt from a City Centre Plaza retailer in the competition period. Note Eftpos machine receipts will not be accepted as a valid Tax Receipt.
- 3. The competition commences on Monday 17 November 2025.
- 4. The competition will close on Thursday 11 December 2025 at 9.00am. The five (5) winners will be drawn shortly after.
- 5. There are five (5) prizes to give away.
- 6. Each prize includes one (1) \$500 City Centre Plaza Gift Card.
- 7. The total prize pool is \$2,500.
- 8. Five (5) winners will be notified by telephone.
- 9. Customers must be 18 years or over to enter.
- 10. The winners must be able to collect their prize from City Centre Plaza within one week of the draw at a suitable time agreed upon by both parties.
- 11. The following persons are not eligible to enter the competition:
